INFORMATION ON HOW WE PROCESS PERSONAL DATA OF APPLICANTS

Your data will be processed for the purpose of:

• if you want to apply for participation in the Orange Fab in your own name, for the purpose of enabling such a participation, in particular to:

- o register a project application under our Program;
- o carry out the pre-selection process aimed at selecting projects for further development work under the our Program;
- o inform about projects selected in the process of pre-selection for further development work under the Orange FAB Program;
- o organize and conduct development works on a project selected in the process of pre-selection; (the legal basis for data processing is your consent);

for the period necessary to register applications, chose the projects in the pre-selection process and conduct acceleration process in line with Orange Fab Program Rules (the legal basis for data processing is entering into a contract and its performance),

• if you accept Orange Fab in the name of other entity – for the purpose of entering into a contract with this entity and performing this contract until the contract is terminated (the legal basis for data processing is the implementation of the our legitimate interest),

- Conduct statistic analysis regarding usage of our Program in the course of the contract and after, until the claims are time-barred (the legal basis for data processing is the implementation of the our legitimate interest),
- proving that we are compliant with law for the period during which we may be fined due to our
 potential lack of compliance (the legal basis for data processing is the implementation of the our
 legitimate interest),
- pursuing claims or defense against claims, including cases of non-compliance by you with the terms of the Orange FAB Program (the legal basis for data processing is the implementation of the our legitimate interest).

If you consent to receiving unsolicited commercial information, we will use your data in order to send such information to you, until you withdraw your consent.

The project application in the Orange FAB Program should include your name and email address. Providing such data is not a statutory requirement, however, it is required if you want to use the opportunity to submit a project application. Failure to provide this data makes it impossible to register the project.

We also process the IP number of the device from which you connect to the registration form, which is a consequence of the technical operation of the website on which the Orange FAB Program application form is placed.

Your data in the above-mentioned scope may be transferred to companies from the Orange Polska SA Capital Group whose list is available at the following link: <u>http://www.orange-ir.pl/pl/the-company/organisation</u> as well as to our technical or IT subcontractors, and the entities which cooperate with us in the organization of the Program.

You have the right to:

• request access to your data processed by Orange Polska,

- rectification (correction) of data,
- deleting data or limiting its processing,

• data transfer, which means that you may receive data processed by Orange Polska or request their transfer to another entity.

In addition, you can object to data processing based on legitimate interest or for the purpose of direct marketing.

The scope of each of the rights and situations in which they can be used arise from the law. The source of your rights will depend, for example, on the legal basis and the purpose of data processing.

If you consider that we process data unlawfully, you may lodge a complaint with the President of the Office for the Protection of Personal Data (Prezes UODO).
